The Company, its successors, assigns and licensees shall have the right to alter, edit, modify, adapt, reproduce and illustrate (as appropriate) the Artwork for use in the Artexpo New York 2017 Poster. All right, title and interest in and to the Poster incorporating the Artwork shall be vested in the Company.

Additionally, I waive any inspection or approval of the finished material and I release the Company from any liability for any claim of alteration, optical illusion or faulty mechanical reproduction.
